# Sage 100 Year End

## YEAR END CHECKLIST

Do you have questions on how to close periods or the year in Sage 100? Luckily we've provided this checklist to answer all of your questions. It guides you through all aspects of your financial reporting process. When you're running a small/medium sized business, every minute counts, especially when the year-end draws closer. Perhaps, you've spent a lot of time trying to set up and understand your Sage 100, but you're not making any headway. We know how it feels.

The newly released Sage 100 year end checklist provides actionable answers to common questions small and medium-sized businesses like yours have about preparing their Sage 100 Year-End. Because, it walks you through each step of the accounting process, enabling you to take care of your entire end-of-year financial reporting yourself.

### **Step 1) This report is what makes up your balance sheet and income statement.**

- Print the General Ledger Trial Balance using the last day of month once all activity for the month has been entered.

### **Step 2) Have you reviewed this for collections and write offs?**

- Print the Customer Aged Receivables Report – a detail list of how much your customers owe your business.
- The Accounts Receivable general ledger account balance found on the General Ledger Trial Balance should = the total amount due found on the Aged Receivables Report

### **Step 3) This report presents money you owe vendors.**

- Print the Vendor Aged Payable Report – a detail list of how much you owe other businesses or individuals
- The Accounts Payable general ledger account balance found on the General Ledger Trial Balance should = the total amount due found on the Aged Payable Report

### **Step 4) This report should represent stock you have on the shelf.**

- Print the last page of the inventory valuation report – a detail list of the items you have in your warehouse and their value.
- The Inventory general ledger account balance found in the General Ledger Trial Balance should = the total inventory valuation amount found on the Inventory Validation Report

### **Step 5) This is the gross wage for your staff.**

- If your company calendar year is January to December, then print the year to date payroll earnings report or get it from your payroll service provider.
- The Payroll Amounts for Salary and Wages Accounts found on the General Ledger Trial Balance should = The total YTD Gross on the Yearly Earnings Report

**Step 6) Do you know how much available cash you have?**

- Perform your monthly bank reconciliation – when completed it should agree to the available cash balance in your checkbook.
- The Cash Accounts general ledger balances found on the General Ledger Trial Balance should = the reconciled checkbook balance once the bank reconciliation has been completed.

**SAGE 100 YEAR END FAQ'S**

**What if I'm a cashed based business?**

- Then the bank reconciliation is a critical step so you confirm all the money you are spending has been recorded and all the money you are being paid and have deposited has been recorded.

**What else do I need to consider?**

- There may be many more steps that need to be completed each month. A month end checklist is important to help you make sure necessary tasks are being completed each month.

**What is my accounting system is not in balance after I complete the month end close checklist?**

- If you find discrepancies on any of these steps, contact your consultant.





# Acumatica Year End

## ACUMATICA YEAR END CLOSING OVERVIEW

In Acumatica ERP, a financial year is closed automatically when you close the last period of the financial year. Therefore, you should close the last period of a particular financial year only when the company is ready to close the financial year.

### The year-end closing includes the following stages:

1. Generating periods for the new year and opening at least one of these periods (this action is performed by using Master Calendar Generation).
2. Carrying out the operations on your company's "year-end" checklist.
3. Closing the last period in the General Ledger module (this action is performed by using Close Financial Periods). See the Closing a Period in Subledgers and Closing a Period in General Ledger section.

During closing of the financial year, the balance of YTD Net Income account updates the Retained Earnings account, which accumulates the net income over years. After that, the balance of the YTD Net Income account is reset to zero for a new financial year. The balances of the balance sheet accounts are transferred into the new financial year, while balances of other accounts are reset to zero.

## ACUMATICA YEAR END CLOSING PROCEDURES

Follow your company's internal procedures to determine the prerequisites to closing a financial period. The following tasks might be required to be completed before performing a period close:

- ✓ Generating recurring documents and releasing them
- ✓ Performing allocations
- ✓ Performing revaluation of currency accounts
- ✓ Release and depreciation of Fixed Assets
- ✓ Tax adjustments
- ✓ Inventory adjustments
- ✓ Generating and reviewing the trial balance

**To close a period in the General Ledger, you must first close the period in the subledger modules that are being used. These include the following:**

- ✓ Accounts Receivable
- ✓ Accounts Payable (at year-end you must print out the 1099-MISC Form report and close the year for 1099 payments)
- ✓ Cash Management
- ✓ Fixed Assets
- ✓ Taxes
- ✓ Inventory

***Optional: You can also close the period in subledgers along with the general ledger after performing period-end activities. Please refer to your company's internal procedures.***

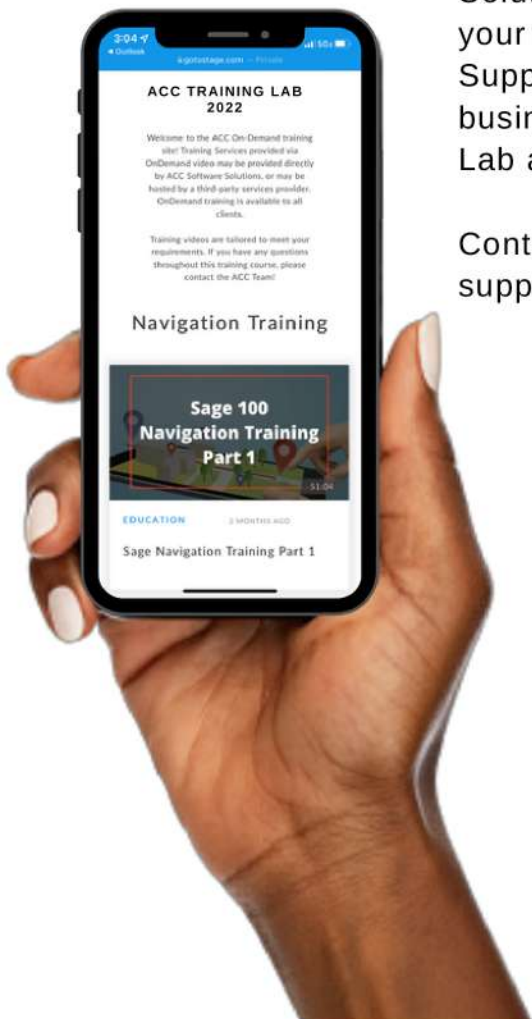
